Ship Visit Event
Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.

1. Eligibility. The Celebrity Cruises Ship Visit Event ("Promotion") is open only to legal residents of the United Kingdom who are eighteen (18) or older at the time of entry. Employees of Sponsors (defined below) and each of their respective related companies, as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Promotion is subject to all federal, state and local laws and regulations and is void where prohibited by law.

2. Sponsor. The Independent Traveler, Inc., 200 Princeton South Corporate Center, Suite 330, Ewing NJ 08628 ("Sponsor") and RCL Cruises Ltd t/a Celebrity Cruises, with its principal office at 3 The Heights, Brooklands, Weybridge KT13 ONY ("Prize Provider").

3. Agreement to Official Rules. Participation in the Promotion constitutes your full and unconditional agreement to these Official Rules and the decisions of Sponsor, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein in a timely manner.

4. Entry Period. The Promotion begins on 6th August, 05:00 hrs Eastern Time ("ET") and ends on 17th August at 07:00 hrs Eastern Time ("ET") (the "Entry Period"). Entries received prior to or after the Entry Period will be disqualified. Sponsor's computer will be the official time-keeping device for the Promotion.

5. Entry. During the Entry Period, provide your name and contact details to competitions@cruisecritic.co.uk. Limit: One entry per person, per day.

6. Selection of Potential Winners. On or about 17th August, 10 tickets will be allocated by selecting at least 20 winners at a random drawing from among all eligible entries received. The potential winners will be notified by email. If a potential winner cannot be contacted within seven (7) days of the first attempt to contact him/her, Prize Provider will select an alternate potential winner in his/her place from among all remaining eligible entries. The odds of winning any prize depend on the number of eligible entries received for the applicable drawing.

7. Requirements of Potential Winners. Except where prohibited, the potential Prize Winners must complete and return an affidavit of eligibility and liability/publicity release (the "Affidavit/Release"), and supply contact information for all attendees, within seven (7) days of being notified. If a potential winner fails to sign and return the Affidavit/Release within the required time period, if notification or prize is returned as undeliverable, or if Sponsor or Prize Provider determines in their sole discretion that the potential winner is ineligible, an alternate entrant will be selected in his/her place. The Prize Winner's travel companion(s) must sign and return a liability/publicity release prior to travel. If travel companion is a minor, the winner must be his/her parent or legal guardian.

8. Grand Prize. The winner ("Prize Winner") will receive a one (1) day Celebrity Cruises Ship Visit to include lunch for the winner plus one (1) guest on Celebrity Silhouette on 9th September. Up to twenty (20) tickets will be awarded. Parking at the port is included. Prize does not include airfare, transport to

the ship, personal expenses, or any other cost or fee associated with prize receipt or use not expressly stated herein. The prize is subject to availability, non-negotiable, non-transferable and non-refundable. Prize Provider reserves the right to alter, amend or foreclose the competition in the event of unforeseen circumstances. The Prize includes parking at the Southampton port and a lunch with wine. Closing date for receipt of entries is 17th August at 07:00hrs Eastern Time. Participants and their guests must be residents of the UK, must hold a valid passport or photo driving license and be over 18 years of age. Participants must bring a valid passport or photo driving license with them on the day of the event. Guests must arrive by 9am latest, and be ready to board by 10am sharp. Failure to arrive at this time, and with a valid photo identification will mean that access onboard is denied. No cash substitution or substitution of prize permitted. Additional restrictions may apply. Any prize details not set forth above will be determined by Prize Provider in its sole discretion. Prize is redeemable only by the named winner and must not be sold on to any other party. Once the booking is confirmed changes to the names, date or nature of the booking are not permitted. Approximate retail value is: \$200. Odds of winning depend on the number of eligible entries received.

9. General Conditions. In the event that the operation, security or administration of the Promotion is impaired in any way for any reason, Sponsor may, in their sole discretion, suspend, modify and/or cancel the Promotion. Sponsor reserves the right in their sole discretion to disqualify any individual they find to be tampering with the operation of the Promotion or to be acting in violation of these Official Rules or in a disruptive manner. Any attempt by any person to undermine the operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that or any other provision. In the event of a dispute as to any entry, the authorized account holder of the email address used to enter will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. In the event that an entry is confirmed to have been erroneously deleted, lost or destroyed, entrant's sole remedy shall be another entry into the Promotion. If any provision of these Official Rules is held to be invalid or unenforceable, such provision shall be struck, and the remaining provisions shall be enforced. The Sponsor reserve the right to alter, amend or foreclose the competition in the event of unforeseen circumstances.

10. Release and Limitation of Liability. By participating in the Promotion, you agree to release and hold harmless the Sponsor and Prize Provider, their respective parent and related companies, and each such company's respective officers, directors, employees, and agents (collectively, the "Released Parties") from and against any claim or cause of action arising out of participation in the Promotion or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Promotion; (b) technical or printing errors; (c) lost, late, postage - due, misdirected or undeliverable mail or email; (d) errors in the administration of the Promotion or the processing of entries; or (e) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from your participation in the Promotion or receipt or use of any prize. You further agree that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Promotion, and in no event shall the Released Parties be liable for attorneys' fees.

11. Disputes. Except where prohibited, you agree that any and all disputes, claims and causes of action arising out of the Promotion or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the State of Massachusetts. All

issues and questions concerning these Official Rules, your rights and obligations, or Sponsor's rights and obligations shall be governed by the laws of the State of Massachusetts, without giving effect to any choice of law or conflict of law rules.

12. Privacy. By participating in this Promotion, you agree that all information that you submit to the Sponsor will be treated in accordance with the Sponsor's and Prize Provider's Privacy Policies, available at <https://www.cruisecritic.co.uk> and www.celebritycruises.co.uk

Data Controller – The Sponsor is the "Data Controller" in relation to processing personal data of participants to the Promotion. Data Controller shall be construed in accordance with the definition as is set out in the General Data Protection Regulation 2016/679. Please note that this Privacy Policy remains without prejudice to the processing of the entrants' personal data.

Purposes for processing personal data in this Promotion - The Sponsor collects the personal data, including a name and email address of entrants exclusively for the purposes of organising the management of the Promotion and communicating with entrants and other related projects run by the Sponsor. Personal data provided by entrants shall only be used in accordance with the Privacy Policy. As permitted in accordance with applicable laws, by entering the Promotion, the entrants agree that their data may be used to contact them in connection with the Promotion and for publicity purposes strictly in connection with the Promotion as stated above.

Consent - By providing personal data to the Sponsor, entrants are consenting to its use in accordance with the Privacy Policy.

Retention of data - The Sponsor will not keep personal data relating to entrants' participation in the Promotion for longer than is necessary for the purposes determined above. Data relating to participants will be retained by the Sponsor for a reasonable period after the Promotion finishes to assist the Sponsor in operating the Promotion in a consistent manner and to deal with any queries relating to the Promotion.

By participating in this Promotion, you agree that your personal data will be transferred to the United States of America in accordance with Sponsor's Privacy Policy. Pursuant to EU law pertaining to data collection and processing, as an EU resident, you have a right of access to, modification of and withdrawal of your personal data.
